

Maybankard a Debit Win RM120,000 at Caltex Promotion

Terms & Conditions

1. The Maybankard Debit Win RM120,000 at Caltex promotion ("Promotion") is organized by Malayan Banking Berhad ("Maybank") in partnership with Chevron Malaysia Limited ("Caltex").
2. The Promotion is open to existing and new Maybankard Visa Debit and Maybankard MasterCard Platinum Debit Cardholders ("Cardholders") during the Promotion Period, excluding employees of Maybankard Debit/Prepaid Bankard Business, its partners, advertising agencies, auditors including their immediate family members and any other persons involved in organizing, promoting and/or conducting this Promotion.
3. Cardholders whose accounts with Maybank which have been suspended, closed or who are in breach of their Agreement with Maybank shall not be eligible for the Promotion or the Prizes.

Promotion Period

4. The Promotion commences on 16th December 2011 and ends on 15th June 2012 ("Promotion Period"), both dates inclusive.

Prizes

5. Caltex Vouchers and Cash ("Prizes") worth a total of RM120,000.00 shall be given away to the winning Cardholders ("Winners").
6. Caltex Vouchers ("Grand Prizes") are in the form of a preloaded card known as StarCash and Cash (Monthly Prize) will be credited into the Cardholders Debit cards account.
7. Two Hundred and Ten (228) Winners shall be selected throughout the Promotion Period as per the summary provided below:-

Qualification Mechanics

8. Entry is automatic subject to meeting the terms and conditions herein. No pre-registration, SMS or promotion entry forms are required.
9. To qualify, a minimum spend of RM30 and above at any Caltex Station (single receipt) on the Card is required during the Promotion Period.
10. Only transactions made on the Debit Card at Caltex Stations meeting the minimum spend requirements as set out herein shall be eligible for the Prizes.

Selection of Winners

11. The Grand Prize(s) will be awarded at the end of the Promotion Period to the THREE (3) Cardholders with the highest number of transactions on their Debit Card made at Caltex Stations in three phase throughout the Promotion Period example as below:
Phase 1 - 16 December 2011 to 15 February 2012
Phase 2 - 16 February 2012 to 15 April 2012
Phase 3 - 16 April 2012 to 15 June 2012
12. In case of a tie in terms of the highest number of transactions, the Grand Prize Winners will then be based on the highest amount in terms of Ringgit spent on their Maybankard Debit Cards.
13. The 75 Monthly Winners will be selected based on the Top 75 customers that have the highest transaction in the two months period. e.g. Total eligible transaction (RM30 above) received for month 1, 16 Dec to 15 Feb = 2000 customers. The winners will be selected based on the top 75 customers that have the highest transactions recorded. In case of a tie in terms of the highest transaction, the 75 Monthly

Prize winners will be selected based on the highest amount spent in Ringgit. For example, if there are 2 winners with the same number of transactions for the 75th winner, the winner will be selected based on the highest spends value in Ringgit. (Winner1 has 50 transactions and spends RM1500 and Winner 2 has 50 transactions and spend RM1550. Winner 2 will be selected).

14. The Grand Prize Winners will be informed at the end of the Promotion Period while the Monthly Winners will be informed by the end of the following month throughout the Promotion Period. Details of the Winners will also be available on www.maybank2u.com

21. The Winners shall not be entitled to any cash compensation, benefits or substitution in any form whatsoever in lieu of the Prizes.

24. For petrol related transactions at the Pump (outdoor), there will be a hold amount of up to RM100 for a maximum of 48 hours from the transaction date and time after which this amount will be released and the actual transaction amount debited to the Cardholders Card account.
25. These terms and conditions shall be governed by the laws of Malaysia, and eligible Cardholders shall be deemed to have agreed to submit to the exclusive jurisdiction of the Malaysian Courts.
