

Caltex Spend & Sweep Promotion Terms & Conditions

Organizer

1. The **Caltex Spend & Sweep** ("Promotion") is organized by Chevron Malaysia Limited ("Chevron" or the "Organizer") and it is a joint collaboration with **MYDIN Mohamed Holdings Berhad**.

Eligibility of participation

2. The Promotion is open to all Caltex JOURNEY™ Card and B Infinite Card Members ("Eligible Participants"), except for the following:
 - a. Employees of Chevron (including its affiliated and related companies) and their immediate family members (children, parents, brothers and sisters, including spouses);
 - b. Employees of Caltex service station operators / retailers / marketers and staff and their immediate family members (children, parents, brothers and sisters, including spouses);
 - c. Employees of MYDIN (including its affiliated and related companies) and their immediate family members (children, parents, brothers and sisters, including spouses);
 - d. Representatives, employees, servants and/or agents of advertising and/or promotion service providers of Chevron and MYDIN (including its affiliated and related companies), and their immediate family members (children, parents, brothers and sisters, including spouses).

Promotion Period

3. The Promotion commences on 15 December 2018 and ends on 15 March 2019 ("Promotion Period"), both dates inclusive. The Organizers reserve the right to, at any time, amend or extend the duration of the Promotion Period as it deems fit.

Qualification Mechanics

4. Interested participants are required to do the following to be eligible for the Promotion:
 - (i) every spend of Ringgit Malaysia Thirty (RM30.00) and above or equivalent of 14 liters and above of fuel in a single receipt on fuel purchases (RON97, RON95 & Diesel) at any Caltex Stations ("Caltex Receipt") using Caltex JOURNEY™ Card and B Infinite Card are eligible to get one (1) entry; and/or
 - (ii) every spend of Ringgit Malaysia Thirty (RM30.00) and above in a single receipt on any purchases at any MYDIN Outlets ("MYDIN Receipt"), customers are eligible to get one (1) entry; and/or
 - (iii) a combination of both a Caltex Receipt and a MYDIN Receipt is equivalent to a bonus entry (i.e. a total of 3 entries).
5. To participate in the Promotion, Eligible Participants must submit the MYDIN Receipt(s) to the contest portal at www.caltexjourney.com.my. All fuel transactions using the Caltex JOURNEY™ Card and B Infinite Card will be automatically recorded hence it is not required to submit the Caltex receipts onto the contest portal .
6. Eligible Participants are required to retain the original receipt of purchase as proof of purchase of the transaction.
7. Any receipt duplication will not be entertained and the prizes will be forfeited if the receipt is not original.

Selection of Winners

8. Based on the Entries earned during the Qualifying Period in the table below, the Eligible Participant shall be shortlisted by the randomizer programme at the end of each month.

9. The monthly winners (“Winners”) who are selected, will be notified by phone via SMS and phone call by BLoyalty, the contest management organizer. Winners need to make the necessary verification in order to be able to attend the Supermarket Sweep event (“Sweep”) at the selected MYDIN locations. Details of the winners will also be available at the end of the promotion at Caltex Malaysia’s Facebook page and website at www.caltex.com.my.

10. Eligible Participants are entitled to win only once. In the event where the Eligible Participant’s entry is drawn more than once, the next selected Winner will be chosen.

11. If the shortlisted Eligible Participant is not contactable after three (3) attempts for whatsoever reason(s) and/or the shortlisted Eligible Participant wishes to withdraw from the Sweep upon being contacted by the BLoyalty representative, he/she shall be disqualified from the Promotion and the next selected Winner will be chosen.

Sweep

12. A total of 35 lucky Winners will be selected to be invited for the Sweep event at the selected MYDIN locations. The Sweep cannot be exchanged for cash.

13. The actual date and time of the Sweep will be announced by the Organizer to the Winners in advance before the Sweep day.

14. If the Winner, due to an unavoidable reason (including but not limited to physical disabilities) requests to substitute with another family member or friend, he / she shall email to or call the BLoyalty representative to inform and give the particulars of the substitute, and submit a duly signed authorization letter.

15. Each Winner will be given a shopping cart and a duration of 3 minutes to do the Sweep. At any time, the Winners may exchange their full shopping cart for a new shopping cart at the designated areas.

16. The following items are not eligible for the Sweep:

- Perishables (veg, meat, fish, fruits)
- Items behind the counter (baby milk powder)

17. All items must be contained within the shopping cart and must not be hung or carried outside of the shopping cart in any way or manner. In the event any items shall drop out of the shopping cart at the expiry of the 3-minute period, the items that have dropped will not be counted.
18. At the 3 minute mark, all Winners must cease all shopping immediately. Referees will be on hand to enforce this hard – stop and will push the shopping carts together with the Winners to the respective cashier counter.
19. In the event that the Winner acts or behaves in a dangerous manner or has caused or is likely to cause damage or injury to other persons or property during the Sweep, the Referees on-hand are entitled to immediately stop the Winner from continuing with his/her participation in the Sweep.
20. All Winners will proceed to the check-out counter and all items within their shopping carts will be paid by the Organizer up to a limit of RM3,000, with any amount surpassing the limit to be borne by the Winner.
21. All broken or damaged items during the Sweep will be considered sold; be it on the floor during the Sweep or in the cart during checkout. Broken and damaged items are non-exchangeable.
22. The following actions by a Winner will result in IMMEDIATE disqualification:
 - a. Usage of violence, both physical and verbal, against any party during and after the Sweep;
 - b. Theft, vandalism and/or deliberate destruction of property;
 - c. Entering any restricted areas. Restricted areas are clearly demarcated with barricades, rope, tape and / or signs;
 - d. Modifying, altering and/or changing any part of the shopping cart;
 - e. Usage of any hover boards, skates, skated boards and/or any other form of wheeled transport;
 - f. No pregnant ladies are allowed to participate in this event. They may nominate a representative to enter the Sweep on their behalf.
23. All Sweep Winners are expected to practice caution and common sense during the Sweep and shall be fully responsible for proper handling and maneuvering of the shopping cart. In case of any accident, injury, damage or claim resulting from participating in this Sweep, the Winner shall be fully and solely liable. All Winners are required to execute the Organizer's standard Indemnity Form before being allowed to participate in the Sweep.
24. The Organizer and the Referees have full discretion in determining whether or not a Winner is in violation of any rules of the Sweep. Any violation shall result in immediate disqualification and forfeiture of any prizes obtained from the Sweep.

General Terms and Conditions

25. By participating in this Promotion, the Eligible Participant expressly agrees and consents to:
 - i. be bound by these terms and conditions and the decisions of the Organizer concerning this Promotion;
 - ii. grant to Chevron, MYDIN and BLoyalty and its authorized advertising or media agencies all consents and waivers necessary for the Eligible Participant's name, likeness and particulars to be used for publicity, marketing and advertising purposes worldwide, without limitation and without compensation, in any manner whatsoever in any part of the world as Chevron, MYDIN or BLoyalty shall in its sole discretion deem fit;
 - iii. allow Chevron, MYDIN and BLoyalty to disclose to any third party the Eligible Participant's personal data for any and all purposes in relation to this Promotion and any other related business activity;

- iv. hold harmless and indemnify Chevron, MYDIN and BLoyalty from any loss or damage suffered during participation in the Sweep or the delivery of prizes.
26. The records of transactions maintained by BLoyalty and the selection of Winners shall be final and conclusive.
27. Chevron reserves the right to select new Winner(s) to substitute any Winner(s) who may be ineligible or disqualified for any reason whatsoever throughout the Promotion Period.
28. Chevron's decision on all matters relating to this Promotion shall be final, conclusive and binding and it shall not be obliged to give any reasons or enter into any correspondence with any person(s) on any matter concerning this Promotion.
29. These terms and conditions shall be governed by the laws of Malaysia, and Eligible Participants shall be deemed to have agreed to submit to the exclusive jurisdiction of the Malaysian Courts.
30. Chevron reserves the rights at its absolute discretion to change, vary, delete or add to any of these terms and conditions without prior notice.

Chevron, its affiliated companies, parents, subsidiaries, advertising and promotional agencies, and all their respective officers, directors, employees, representatives and agents will not be held responsible or liable for any personal injury or mishap or damage to property caused during the Sweep and shall be indemnified against any injuries, losses or damages of any kind to any person, including death, or property, resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any of the items or pertaining to the quality/safety/fitness for use/suitability of any of the items obtained during the Sweep.
32. These Terms and Conditions, as may be amended from time to time, shall prevail over any provisions or representations contained in any other promotional material or advertising of this Promotion.
33. Chevron reserves the right to cancel, terminate, suspend or replace this Promotion (or any part thereof) with or without any prior notice and shall not be liable for any claim or compensation in respect of such cancellation, termination, suspension or replacement.
