

## **Caltex Singapore Batmobile Campaign – Halloween Dress-up Giveaway Terms and Conditions (Draft)**

The following terms and conditions apply to Batmobile Campaign Halloween Dress-up Giveaway (“**Giveaway**”) by or on behalf of members of Caltex Singapore Pte Ltd (the “**Organiser**”). In the event of any inconsistency between these Terms and Conditions with any advertising, promotional or publicity materials in relation to, or in connection with the Promotion, these Terms and Conditions shall prevail:

1. No purchase is necessary to redeem.
