

Terms and Conditions
Caltex Chinese New Year Campaign 2023 (“Promotion”).

Organizer:

- This Promotion is organized by Chevron Singapore Pte. Ltd. (“**Chevron**”). Participation in the Promotion is subject to the terms and conditions set out herein and as may be revised by Chevron from time to time at its sole discretion.

Eligibility:

- This Promotion is open to all CaltexGO customers (“**Promotion Entrant**”).

Promotion Period:

- The Promotion period is from 3 January to 31 January 2023 (“**Promotion Period**”) or until the Star Mart e-vouchers (“**Vouchers**”) are fully distributed, whichever is earlier.

Mechanics:

- The Promotion Entrant is entitled, while stocks last, to receive one Voucher with a minimum of \$68 gross spend on fuel at any Caltex service station in Singapore during the Promotion Period. Each Promotion Entrant is limited to one (1) Voucher per transaction regardless of amount spent.
- Vouchers will be valid for redemption at any Caltex Star Marts from 3 January 2023 to 15 February 2023 (“**Redemption Period**”). Any unused Vouchers will be forfeited.

Vouchers:

- Each Voucher entitles the Promotion Entrant to \$10 off Star Mart purchases (excluding controlled items) with a minimum spend of \$50 on Star Mart purchases (excluding controlled items).
- Controlled items include but are not limited to the following:
 - Tobacco products
 - Parking coupons
 - Phone cards
 - Prepaid cards

- Only one (1) Voucher can be used per transaction and must be used immediately upon redemption. The full value of the Voucher will be deducted and no refund in cash or otherwise will be given for partial use. The unused value of the Voucher will be forfeited upon redemption.
- Vouchers can be used in conjunction with any bank promotions relating to Star Mart items.
- Vouchers are non-transferable, non-replaceable and cannot be exchanged for cash or any other items or benefits. However, Chevron is entitled to replace Vouchers with item(s) of similar or other value, or withdraw or add any voucher(s), at any time without prior notice or liability.
