

Terms & Conditions

Caltex September – October Special Local Sites Promotion 2022 (“Promotion”).

Organizer:

- This Promotion is organized by Chevron Singapore Pte. Ltd. (“**Chevron**”). Participation in the Promotion is subject to the terms and conditions set out herein which may be revised by Chevron from time to time at its sole discretion.

Eligibility:

- The following customers (“**Eligible Customers**”) are eligible to participate in this Promotion:
 - All non-CaltexGO customers of Caltex Binjai Park, Caltex Dunearn, Caltex Holland and Caltex Whitley (“**Participating Stations**”), except customers purchasing fuel under Grab Partner Program, Star Driver Program, Cabbie21 Drivers, Caltex Bus Diesel Program Customers and Caltex StarCard customers.
 - All CaltexGO customers who have received the promotion eDM(s).

Promotion Period and Redemption Period:

- The promotion period (“**Promotion Period**”) shall commence on 1 September 2022 and end on 31 October 2022.
- The redemption period (“**Redemption Period**”) shall commence on 1 September 2022 and end on 20 November 2022 or until allocated quantities of Techron® Concentrate Plus and Havoline® ProDS Fully Synthetic LE SAE 5W-40 are fully distributed, whichever is earlier.

Mechanics:

- An Eligible Customer is entitled, while stocks last, to receive one Techron® Concentrate Plus (355 milliliters) or one Havoline® ProDS Fully Synthetic LE SAE 5W-40 (1 liter) (“**Prize**”) with an accumulated gross spend of SGD500 worth of Caltex petrol with Techron® at the Participating Stations during the Promotion Period.
