

Caltex Marvel Thor Fuel Campaign – Pump & Win Lucky Draw Terms and Conditions

The following terms and conditions apply to Caltex Marvel Thor Fuel Campaign – Pump & Win Lucky Draw (“**Draw**”) by or on behalf of members of Caltex Singapore Pte Ltd (the “**Organiser**”). All promotional materials, including details on participation form part of these Terms and Conditions. In the event of any inconsistency between these Terms and Conditions with any advertising, promotional or publicity materials in relation to, or in connection with the Promotion, these Terms and Conditions shall prevail:

1. The Draw is open to customers who have on 16 July 2022, between 0001 hours and 1600 hours made at Caltex East Coast station, (i) a minimum \$70 gross fuel spend and (ii) paid for the purchase with their OCBC card (“**Eligible Customers**”).
2. Eligible Customers stand a chance to win a Mighty Thor Mjolnir Electronic Hammer worth \$279.90 (“**Prize**”).
3. To participate in the Draw, Eligible Customers are required to drop their fuel transaction receipts on 16 July 2022 into a designated Draw box placed at Caltex East Coast station. Eligible Customers are responsible for ensuring their contact details are written on the back of the fuel receipt before dropping it into the Draw box.
4. The Draw will be held on on 16 July 2022, at [1601] hours at Caltex East Coast station. A disc jockey on site will pick fuel receipts from the Draw box to select 5 winners (“**Winners**”) from the Eligible Customers. [If a selected fuel receipt does not contain contact details of the Eligible Customer, the fuel receipt will be discarded and a new fuel receipt picked.]
5. Winners will be contacted via phone call or email by the Organiser from 18 July 2022 onwards. Prize(s) must be collected at Caltex East Coast station on or before 24 July 2022. Prize(s) not collected by 24 July 2022 will be dealt with by the Organiser in its sole discretion as it deems fit without further notice or compensation whatsoever to the Winner(s).
6. During the Draw and/or collection of the Prize(s), Eligible Customers may have their photos taken by the Organiser’s station staff for sharing on Caltex social media. By participating, Eligible Customers agree to have their photos/videos taken for marketing and publicity purposes, including but not limited to, print, audio-visual and social media.
7. The Organiser is not responsible for any personal loss, injuries or damage caused or incurred during or in any way related to this Draw.
8. Eligibility for the Draw shall be determined by the Organiser in its sole discretion. The Organiser reserves the right to disqualify participation by any person at its sole discretion. In the event of a dispute, the Organiser’s decision is final and no correspondence will be entertained.

9. Draw Prizes are final, non-refundable, non-exchangeable and cannot be redeemed or exchanged for cash. The management reserves the right, in its absolute discretion, to replace the Prize with item(s) of similar value at any point and without prior notice.

11. The Organiser reserves the right to partially or completely cancel, modify, terminate or suspend the Draw for any reason without prior notice or any liability whatsoever.

In no event will the Organiser, its parent, affiliates, subsidiaries and related companies, their respective advertising or promotion agencies or their respective officers, directors, employees, members, shareholders, attorneys, representatives and agents (collectively, "**Affiliates**"), be responsible or liable for any damages or losses of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of the participation in the Draw. By entering into the Draw, participants hereby release and agree to hold harmless. The Organiser and their Affiliates from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that they may have, or which may arise, whether in whole or in part, and whether directly or indirectly.

To the fullest extent permissible under applicable laws, the Organiser shall not be liable to any participant or any person in respect of or arising from or in any way connected to the Draw under any circumstance whatsoever and howsoever arising. If the Organiser is deemed liable to such participant or other person by a court of law, the sole remedy shall be the award of the Prize or a substitute of similar value as determined by the Organiser in its sole discretion, to such a participant or person.
14. This Draw and the Terms and Conditions shall be governed by the laws of the Republic of Singapore. The parties hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
