

# Terms & Conditions

## Caltex Justice League Promotion 2023 ("Promotion").

### Organizer:

- This Promotion is organized by Chevron Singapore Pte. Ltd. ("**Chevron**"). Participation in the Promotion is subject to the terms and conditions set out herein and as may be revised by Chevron from time to time at its own discretion and without prior notice.

- This Promotion is exclusively for all Caltex customers ("**Caltex Customers**") and/or Trust Bank Cardholders who make fuel payment with a valid Trust Credit / Debit card during the Promotion Period ("**Trust Customers**").

- The Promotion period ("**Promotion Period**") shall commence on 19 May 2023 at 0700 hours and end on 16 July 2023 at 2359 hours or until all Justice League merchandise are sold out, whichever is earlier.
